I, Susan Blankenship, City Clerk of the City of South Lake Tahoe, County of El Dorado, State of California, hereby certify that:


The petition entitled ***"An Initiative Measure to Establish a Tax on Owners of Vacant Residential Units in the City of South Lake Tahoe"*** was filed with the City Clerk's Office on April 22, 2024.

That said petition consisted of 2,471 signatures purporting to be signatures of qualified electors of the City of South Lake Tahoe, California.

That after the proponents filed the petition and based on the County of El Dorado Elections Department's examination of signatures and certification (full check, attached), the petition exceeded the necessary number of valid signatures (1,159 or 10% of registered voters of the City of South Lake Tahoe at the time the Notice of Intent to Circulate was published) to qualify.

Based on the above, the petition is deemed to be sufficient.
